AMNESTY IMPLEMENTATION PRINCIPLES FOR STUDENTS WHO WILL START THEIR STUDY WITH THE TEMPORARY ARTICLE 83 ADDED TO THE LAW NO 2547 BY ARTICLE 35 OF THE LAW NUMBER 7417

- 1. Terror within the scope of the Anti-Terror Law No. 3713 dated 12/4/1991, wilful killing within the scope of the Turkish Penal Code No. 5237 dated 26/9/2004 (articles 81, 82 and 83), torture (articles 94 and 95), torment (article 96), sexual assault (article 102), sexual abuse of children (article 103), manufacture and trade of drugs or stimulants (article 188) or the acts written in Article 71 of the Law No. 5846 on Intellectual and Artistic Works, membership, affiliation or affiliation with or contact with terrorist organizations or structures, formations or groups determined by the National Security Council to be operating against the national security of the State, except for those who are dismissed on the grounds that they registered using fake or untrue documents,
 - a) Students who were discharged before 05.07.2022,
 - b) Students who have not registered before 05.07.2022,

Their applications are received by the Registrar's Office until 07.11.2022.

- 2. Those who apply until 07/09/2022 to benefit from this law are registered for the 2022-2023 Academic Year Fall Semester, and those who apply between 08/09/2022-07/11/2022 are registered for the 2022-2023 Academic Year Spring Semester.
- 3. Those, who cannot apply due to force majeure within the application period, within one month from the date when the force majeure disappears, and those who cannot apply due to health reasons, can submit the relevant committee report by the end of the working day on 05.12.2022.
- 4. If there is no judicial decision regarding the use of citizenship rights, applications are received from persons who have been/removed from the citizenship of the Republic of Turkey and have become a foreign national after their exmatriculation from our Institute.
- 5. Students who have been discharged from the Double Major and/or Minor Program are re-registered to the Minor and/or Double Major program.
- 6. If those who leave an undergraduate program with an associate degree diploma deserve to graduate from the undergraduate program, their associate degree diplomas are cancelled.
- 7. The students whose applications are accepted are determined by the relevant department/department proposal and the Faculty/Graduate Education Institute Administrative Board for the semester in which they are accepted.

For students who have been discharged from or placed in graduate programs whose student admission has been stopped or closed, one of the graduate programs that are still accepting students, the procedures regarding the registration of the student with the consent of the student are determined by the Graduate Education Institute Administrative Board. Among the students who applied to benefit from the amnesty law, students who were discharged while enrolled in graduate programs that were closed/student admission was stopped;

a) Students who have completed their courses but are in the thesis stage are registered to the program that has been closed/student admission has been stopped, and their thesis period is processed.

- b) Students who have not completed the course phase are adapted to the current graduate programs.
- c) Students who want to transfer to graduate programs in another higher education institution can transfer according to the Postgraduate Education and Training Regulations, like the students registered in other graduate programs.
- 8. The maximum education period of the program students whose applications are accepted is calculated by subtracting the duration of the class/semester in which they are accepted (adjusted) from the maximum education period of the program.
- 9. If the central placement (ÖSYS/YKS/DGS) score of the undergraduate students enrolled in other higher education institutions within the scope of amnesty is equal or higher than the base score of the diploma program in the same year in the same year, their application is accepted.
- 10. Transfer applications to the programs that are not available in our Institute as of the year in which the student is registered with the ÖSYS/YKS/DGS score, or for which students are not accepted, are processed according to the ÖSYS/YKS/DGS base scores of 2022. Applications of students who cannot meet the aforementioned base score requirements will not be evaluated.
- 11. Transfer applications to undergraduate programs within the scope of amnesty are only accepted for the Fall or Spring semesters of the 2022-2023 Academic Year. Applications are made until 09.09.2022 for the Fall Semester, and between 12.09-30.12.2022 for the Spring Semester.
- 12. The English Placement Exam of the students who applied for lateral transfer for the Fall Semester of the 2022-2023 Academic Year, on 13.09.2022 (1st Stage) and 16.09.2022 (2nd Stage); The English Placement Exam for the students who apply for the Spring Semester is held on 26.01.2023.
- 13. The applications of those who do not meet the conditions for exemption from the preparatory class in the IZTECH School of Foreign Languages Department of Basic English Preparatory Class Regulations, among those who apply for lateral transfer to the undergraduate programs of our institute, will not be evaluated.
- 14. Among the students who have been discharged from the graduate programs, those who have been granted the right to become a student by applying to the higher education institution they have been discharged from, can transfer within the framework of the conditions stipulated by the "Graduate Education and Training Regulations.
- 15. SBS (English proficiency exam) is given to undergraduate and graduate students who have been discharged from the English preparatory class (with the decision of the board of directors or by their own request), who have earned the right to enroll but have never studied in the preparatory class. Those who do not get enough points in this exam are given the right to study for 2 years.
- 16. If students who have been dismissed from the English Preparatory Class and/or have never registered before, apply until 09.09.2022, the English Placement Exam is held on 13.09.2022 (1st Stage) and 16.09.2022 (2nd Stage). For students who applied between 10.09.2022 and 07.11.2022, it is done on 09.11.2022 (1st Stage) and 10.11.2022 (2nd Stage).
- 17. Those who are accepted to the Secondary Education Non-Thesis Master's Programs but fail to meet at least one of the English preparatory class exemption requirements of the IZTECH School of Foreign Languages cannot be registered.
- 18. In case of re-registration of the program within the scope of the amnesty law, the students who have not been accepted to the doctoral program before the 2007-2008 Academic Year Spring Semester, or who were made exmatriculation before the Ph.D. qualifying exam stage or at the stage of the Ph.D. qualifying exam, those who have obtained a

- minimum score of 55 from YÖKDİL, e-YÖKDİL, YDS, e-YDS, which is not older than five years from the date of entrance, or at least 66 points from TOEFL (IBT), which is not older than 2 years, as an English language score while taking the Ph.D. qualifying exam submits the language documents to the relevant department heads. Students who cannot submit a valid language document are not taken to the Ph.D. qualifying exam. These students are dismissed from their programs in accordance with the fourth paragraph of article 34 of the IZTECH Graduate Education Regulation.
- 19. Within the framework of the decision of the Higher Education Council that the students still enrolled in the undergraduate program cannot continue their education in another formal program at the same level at the same time, provided that the students in this situation who apply to a formal program at the same level as the program they are registered with, cancel their registration from the formal higher education program they are still attending, enrollment is made in the program to which they have previously registered or earned the right to enroll.
- 20. Considering that students who are currently enrolled in a postgraduate program excluding non-thesis master's degree can only be enrolled in one postgraduate program in accordance with the provisions of the Postgraduate Education Regulation, Students in this situation are registered to the postgraduate program they were registered or entitled to enroll in before, provided that they cancel their registration in the graduate program, except for the non-thesis master's degree they are still continuing.
- 21. Students who have the right to enroll in more than one higher education institution before 05/07/2022 are registered in only one of them under amnesty.
- 22. In the calculation of the contribution fees by the Registrar's Office, the education period before the exmatriculation of the students is also included in the calculation of the contribution fee.
- 23. Students who have been discharged from joint graduate programs;
 - a) In case there is a graduate program with the same or similar name as the joint graduate program, registration is made for this program.
 - b) In the absence of a program with the same name as the joint graduate program, the procedure is carried out as in other graduate programs that are closed.
- 25. The minimum period is not taken into account for students who are in the thesis period and want to submit their thesis immediately.
- 26. The number of advisors of the faculty members and the number of advisors in Article 35/3 of the Graduate Education and Training Regulation of the Council of Higher Education are increased by 50%, taking into account the students who return by taking advantage of the amnesty.
- 27. Students registered under the amnesty law are subject to the provisions of the current IZTECH legislation.
